Agenda Items:

1. Review of 08/17/11 meeting and 09/28/11 workshop minutes.

A motion to accept the minutes was made by Mr. Brobst and seconded by Mr. Van Gaasbeek. The minutes were approved unanimously.

2. Revenue Share Update

Ms. Labbe provided a handout and reviewed the responses received from the Revenue Share Questionnaire previously sent to all Board members. The Committee discussed the responses. Mr. Moon stated that further discussion would be held at the November meeting with some form of recommendation sent to the Finance Committee for further consideration at that time.

3. Open House Update

Ms. Dunn provided a handout and updated the Committee on the annual Open House. Attendance was estimated at 254.

4. eco-Excellence Award Nomination Request Review

Ms. Dunn reminded the Committee that eco-Excellence Award nominations were being sought. The information is currently on the **ecomaine** website and nomination forms were available for anyone to take. Nominations are due by January 20, 2012.

5. Recycling Updates

Current Market Conditions

Mr. Roche updated the Committee on current conditions of the recycling commodities markets and material movement.

Tonnage and Marketing Reports

Ms. Labbe went over current recycling tonnage for September, 2011, which was 3101.54 tons.

Revenue and Expense Report

Ms. Labbe reviewed the revenue and expense reports for September, 2011.

Website Analytics

Ms. Dunn reviewed recent website traffic and statistics.

Outreach and Tour Report

Ms. Labbe updated the Committee on the number of tours done in September and the outreach conducted. 230 individuals toured **ecomaine** in September.

Catalog Choice Report

Ms. Dunn provided a handout and updated the Committee on the current status of Catalog Choice memberships. Currently, 156 households and businesses have taken advantage of this free registry designed to reduce unwanted mail.

6. Other

E-Bulletin Board - Ms. Dunn discussed the current use of the e-board. There has been very limited utilization by those towns that opted to participate. She encouraged members to encourage their town to log on and add content whenever possible.

Ashfill Mining Operation - Mr. Roche updated the Committee on the status of the ashfill mining operation at the **ecomaine** ashfill. They have begun to set up and should begin mining in the next 30 days.

Silver Bullet Painting Contest - The second silver bullet has been completed and was on site for everyone to view. This silver bullet was decorated by the students of Wells (Ogunquit) High School as part of the painting contest. This silver bullet will be allocated to Scarborough, since Ogunquit does not utilize these containers.

Dear Troy,

Thank You for the opportunity to comment on the recycling revenue sharing concept being discussed by the recycling committee. I applaud the committee's efforts to bring more tons into the recycling facility to make sure it runs at or near capacity.

Councilor Ahlquist and I met to discuss the example of revenue sharing provided in your letter dated 10/07/2011. This formula or one similar to it would have the benefit of providing incentive to communities to recycle at ECOMaine because they would see benefit in the form of money paid back to them. The downside to the revenue sharing program is that the chances of everyone feeling the formula is equitable to all are slim. Furthermore, we feel that the communities currently not participating to the fullest extent in the program are unlikely to change regardless of sharing in the revenue or not. While the reasons are varied as to why some towns choose to not participate fully in our recycling program one thing is for sure – the reasons are well rooted and long standing.

The process of what is done with excess revenue has been talked about a number of times in board meetings. The common sentiment is to put surplus funds towards debt pay down and assessment relief. Both Councilor Ahlquist and I still feel this is the best approach at this time.

We encourage the committee to continue working with staff to find ways to incentivize maximum use of all of the facilities at ECOMaine. It is our hope that program changes will be made deliberately and with all options weighed.

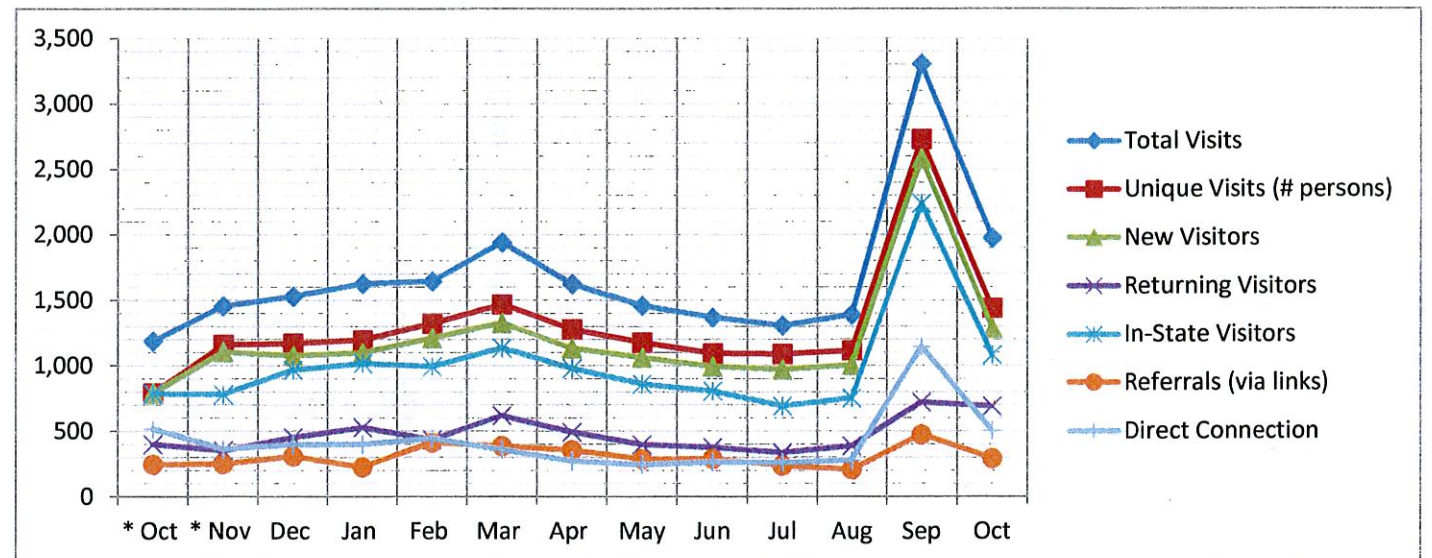

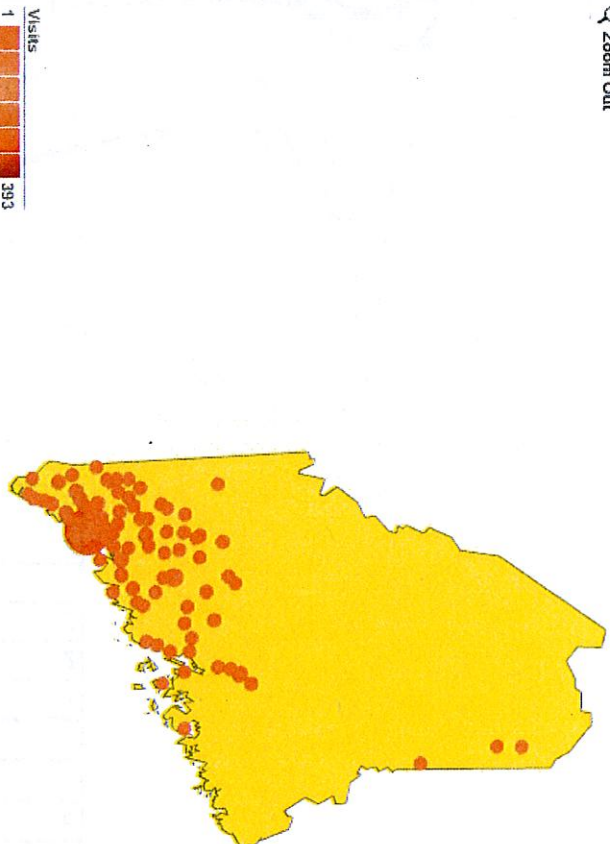
