**SUBJECT:** Outreach & Recycling Committee Minutes – April 5, 2018

The **ecomaine** Outreach & Recycling Committee met April 5. The meeting was called to order by Committee Chair Caleb Hemphill, who suggested changing the agenda to move the Outreach & Educations, updates on School Recycling Grants and the Recycling Market Report to be earlier in the agenda. All approved.

- 1. Approval of Minutes (*Attachment A1 and A2*)
  - Jamie Garvin moved to approve both minutes, Bob Randall seconded and all unanimously approved.

#### 2. Outreach & Education

- Katrina reviewed the education & outreach report, and Lisa handed out an executive summary about the Red Claws/City of Portland recycling program results (*Attachment B1*)
- Lisa reviewed the ecomaine Website & Media Analytics (Attachment B2)

#### Grants:

- Update on School Recycling Grants Program: Katrina shared an update that Waterboro Elementary School would be returning \$900 of their grant because the PTO ended up covering the food waste hauling costs, and the Albert D Hall school in Waterville would be returning the \$840 grant they received to receive Agri-Cycle hauling for the school due to the unavailability of the parent who had offered to lead that project. Given that the budget had gone over by \$1,158 dollars, this returned funding will help to balance a budget that is expected to go over this year.
- There was a discussion on future grant programs including grant spending, grants afor tours, targeting age groups for tours and curriculum.
- 3. Recycling Market Report (*C*) Lisa reviewed the recycling market report and gave an update on the situation in China, which is affecting movement and sales of paper at the moment.

- 4. Recycling is a Work of Art Contest
  - There were 20 submissions to this year's Recycling is a Work of Art Contest. The judges reviewed all submissions and selected the following to receive the six awards:





#### **RECYCLOPEDIA:**

- A total of 64,065 items have been searched on the RECYCLOPEDIA
- App downloads stand at 2,359, with 462 new downloads in August. The widget on web pages has been viewed 46,190 times.
- The top 10 searches are: plastic bag, Styrofoam, plastic straws, milk cartons, plastic bottle caps, almond milk cartons, aluminum foil, batteries, plastic utensils, and plastic bread bags.


#### Facebook:

- 2,052 total likes (+59 in August; +636 from August 2017)
- When we reached 2,000 followers, we were able to embed the Recyclopedia on our Facebook page; we ran a promotion to gain new followers to this end.
- Our top organic post was on August 2 (reaching 5,150 people), was a post of our Do/Don't Card.
- Average daily organic post reach by month is as follows: May 571; June 653; July 1,127; August 1,226.

#### Twitter:


- We gained 23 new followers in June, 14 new followers in July, and 6 in August for a total of 649.
- We earned 14,900 tweet impressions in May / 16,000 in June / 20,500 in July / 17,800 in August with the top tweet being our share of the Press Herald's July 22 front-page article (4,846 impressions **3x** our previous high for this category).

**Instagram:** We had 25 Instagram posts in June (712 likes), 25 posts in July (673 likes), and 27 in August (664 likes). We gained 110 new followers for a total of 571.



#### Website:


- Web traffic spiked on May 4-6 with our recycling contamination press conference.
- Pageviews are up 64% over last year.
  - o The RECYCLOPEDIA is the second-most-used page, with a high 3,693 pageviews in May, when it was the most-visited page.
  - o Bounce Rate has continued to decrease over the summer, meaning more interaction and time spent on our page.



#### **Earned Media:**

FY18 was a good year for ecomaine, with 84 press mentions – 22 more than FY17 and 34 more than FY16. FY19 is shaping up to have even more, since we've already seen 68, thanks to the recent PPH story generating local follow ups as well as a story that hit the AP wire that was picked up nationally.

Press outreach has been steady, from all kinds of outlets: NewsCenter and WMTW on TV, Maine Public Radio, the Press Herald, Forecaster, and many community papers, as well as online distribution of all these stories – USA Today and Huffington Post both used some ecomaine photos recently, as well.

In FY18, the ecomaine Recycling & Outreach Committee decided to award fifteen Maine schools with funds and/or goods valued at a total of **\$21,168**. Below is a summary of grant recipients, who were chosen based on the following criteria: (1) project outline and school commitment (2) ease of project replication (3) likelihood of success and program sustainability, and (4) how compelling and worthy the funding proposal was.

**Albert S. Hall School**, Waterville, was awarded **\$840** for Agri-Cycle food waste pickup to divert food waste from school trash.

• Did not go through with grant as they didn't have bandwidth to execute program.

**Camden Hills Regional High School,** Camden, total grant of **\$1,470** included: \$930 for a debris shredder, \$150 for a shredder shed, \$265 for bins and a scale, \$75 for a wagon and \$50 for snow fencing. Their goal was to shred all compostable material and work with Mark King for a much higher landfill diversion from cafeteria.

**Deering High School,** Portland, was given a total grant of **\$900** to buy sheds for recycling and compost bins to deter both human and animal vandals. Goal was to have successful food and recycling diversion program.

**East End Community School,** Portland, total grant of **\$500** for: bussing of 4<sup>th</sup> and 5<sup>th</sup> grade students for an ecomaine field trip. Their goal was to make a slide show to share with the school to extend the knowledge gained from the field trip to more students.

In the end, they only needed \$400 for bussing

**Harold B. Emery Elementary School,** Limington, total grant of up to \$5,000 to implement a more sustainable recyclables collection and hauling from school to increase school's overall recycling rate. We consulted to identify the specific expenditures to be covered by this grant in advance of allocating funds.

• Did not go through with grant as leader couldn't find a hauler to pick up or rent dumpster from. Given a no-cost extension of one year. No funds changed hands.

**King Middle School**, Portland, total grant award of **\$1,460**, including: \$590 for a triple sorting station, \$60 for a lid and funnel to empty liquids, and \$800 to retrofit a water bottle filling station. Installing this streamlined station further reduced their impact on the earth by reducing dependence on single-use water bottles.

**Lake Region Middle School,** Naples, total grant of **\$1,000** for food waste pick-up plus some bins. School won grant last year as well, to build compost bins on site but wanted option for winter months and non-backyard compostable items. They want to remove all food waste from trash, entire school was involved with videos, posters, website, brochures, etc.



**Mast Landing School,** Freeport, was given a total grant of **\$680** for eight months of We Compost It! food waste pickup. School intends to sustainably fund this program to continue offering this valuable service for the foreseeable future!

**Medomak Middle School,** Washington/Union, total award of **\$650** toward purchasing: a scale, two 50-gallon recycling containers, gloves and 10-gallon recycling bins. We also donated ten 22-gallon ecomaine recycling bins for redeemable bottle collection. Goal was to do trash audits to increase diversion rates.

**Pond Cove Elementary,** Cape Elizabeth, total grant of \$2,000 for: four 4-bin indoor sorting systems. Bins assist in proper sorting of waste materials by students and staff. Hope is to have more recycling with 0% contamination.

**Pownal Elementary School,** Pownal, total grant of **\$430**, including: \$216 for eco-friendly leftovers containers, \$180 for a composting bin plus \$22 for a compost starter kit and \$12 for peat moss. Their goal was to compost their own food for their student garden, while learning how waste can be a valuable resource as well as lower food insecurity and food wasted each week.

**Scarborough High School,** Scarborough, total grant of \$318 for: pressure-treated pine, chicken wire netting, a staple gun, posts and screws. Goal was to build a winter/outdoor composting bin set for waste Garbage to Garden won't take from gardening practices, built by students with help from community,

**Shapleigh Memorial School,** Shapleigh, total grant of **\$2,200**, includes: \$300 for bussing, \$300 for project materials, \$500 for cafeteria bins, \$200 for small recycling bins, and \$900 for food waste hauling. They receive a monthly pickup of all kitchen, lunch, and snack food waste in efforts to cut down on the amount of food in their trash. Bins assist in proper sorting of waste materials by students and staff.

**Waterboro Elementary School,** Waterboro, total award of **\$2,700** includes: \$300 for bussing, \$500 for project materials, \$120 for buckets, \$100 for gloves and \$900 for food waste hauling. ecomaine donated food waste pails with lids.

**Yarmouth High School**, Yarmouth, total grant of **\$1,020** to include: materials to build indoor waste sorting station. Bins assist in proper sorting of waste materials by students and staff.

• Final 20% never paid out as the School did not return their final reports. Multiple contacts attempted.

In FY18, ecomaine paid \$15,024 in School Recycling Grants, with Harold B. Emery Elementary School (Limington) receiving a one year extension on \$5,000; Albert S. Hall (Waterville) pulling out of the grant (\$840); and Yarmouth High School (Yarmouth, \$204) and East End Community School (Portland, \$100) relinquishing their remaining 20%.

## School Recycling Grant Guidelines

Goal: To provide monetary resources that will help schools reach goals to reduce solid waste disposal and/or increase recycling, compost, and landfill diversion rates.

#### 1. Grant eligibility

- a. School must serve students that live in a municipality served by or affiliated with ecomaine. (Visit ecomaine.org/about-ecomaine/ecomaine-communities for a full list of communities.)
- School may be public or private and of any grade levels (including post-high school).
- c. School must agree to provide two progress reports to ecomaine: at the midpoint (March 1, 2019) and upon the completion date (no later than May 31, 2019).
- School must be willing to freely share its program and results with other schools for replication purposes.
- e. Grantees agree to coordinate with ecomaine Education staff for a free on-site visit to engage with school staff and/or students to promote greatest efficacy of grant funds.

#### 2. Grant money available

- a. ecomaine will make school grants available from a pool of \$25,000.
- b. School may apply for a grant in any amount up to \$5,000.
- c. Money awarded by ecomaine must be spent in accordance with the applicant's submission to ecomaine.
- d. Grant monies will be awarded to schools, not individuals.
- e. Grant monies will be dispersed:
  - i. Eighty percent (80%) upon initial award.
  - Twenty percent (20%) upon completion of the final project report\*.

#### 3. Grant Application

- Applications are due by October 19, 2018; late applications will not be considered.
- Grant applications must be signed by the school's principal, superintendent, or president.
- c. Applications must include specifics that address these judging criteria:
  - i. Project outline and school commitment
  - ii. Ease of project replication
  - iii. Likelihood of success and program sustainability
  - iv. Why the project is compelling and worthy of funding
- d. Applications will be judged by ecomaine's Recycling Committee.

If selected, school recipients can receive up to \$5,000 of \$25,000 in available grant funds for the 2018-19 school year. Recipients are chosen based on the following criteria:

- (1) Project outline and school commitment
- (2) Ease of project replication
- (3) Likelihood of success and program sustainability
- (4) How compelling and worthy the funding is

In fiscal year 2018, ecomaine reached more than 25,000 school children and members of the public through grants, tours, presentations and events. "It's so important to teach our kids about recycling right and promoting safe, sustainable ways to deal with their waste. The impact, when they share what they learn with their friends and families, is enormous," said Katrina Venhuizen, ecomaine's Senior Environmental Educator.

In addition to the School Recycling Grants, other programs that ecomaine offers throughout the year to further its education and outreach mission are:

- Recycling is a Work of Art contest (6 winners selected in Spring to paint murals on the "silver bullet" recycling containers in towns)
- Eco-Excellence Awards (annual March awards, nominations accepted throughout the year)
- Annual Recycling Open House (this year's is September 29, 2018!)
- On-site tours and community outreach (ongoing)

Following the October 19 deadline, proposals will be reviewed by ecomaine's Outreach & Recycling Committee, and winners will be notified by mid-November.
