Position Summary:

Under general supervision, this position will perform a variety of tasks related to maintenance and repair activities of plant equipment and facilities. This position centers around the ability to repair and maintain plant equipment so that it will continue to operate efficiently.

Functions and Responsibilities:

- Perform routine, preventive maintenance on plant equipment and facilities as directed
- Perform corrective and emergency mechanical maintenance repairs as required
- Perform inspections, equipment tests; trouble shoots and repairs plant mechanical equipment
- Perform routine welding and fabrication in the repair and maintenance of plant equipment and facilities
- Make out clear and accurate reports on equipment and write other reports as required.
- Maintain a high level of job safety
- Operate and maintain various heavy equipment, such as mobile crane, overhead crane, forklifts, loader, etc., in performance of maintenance work
- Maintain clean and safe operating condition of maintenance equipment and tools.
- Maintains reports and records as required for maintenance control
- Operates and maintains machine shop equipment
- Available for call-ins
- Other duties as assigned
